Salon Mickey – Internal Regulations

Applicable as of January 24th, 2022

Closure of the Salon Mickey

Salon Mickey will close for a period of 4 weeks **between Monday January 24, 2022 and Sunday February 20, 2022 inclusive** to carry out some beautification work.

This Internal Regulations will be applicable throughout the duration of the work.

Preamble

Euro Disney Associés S.A.S. offers members of the Euro Disney Club (hereafter “Members of the Club”) the opportunity to start their visit at Disneyland® Park and/or Walt Disney Studios® Park with light refreshments.

During the closure of Salon Mickey for renovations, **Pause Gourmande (Tea Time Treat)** Vouchers valid in the Disney Parks will be allocated to you for these light refreshments. The Pause Gourmande Vouchers can be collected at the **window located on the right side of the Donald Desk** at the entrance of Disneyland Park. Please read the conditions for the allocation and use of the Pause Gourmande Vouchers in Articles 1 and 3 of these Internal Regulations.

The present internal regulations are an integral part of the General Conditions of the Euro Disney Club (available on <http://disneylandparis-news.com/en/>) and ensure proper operations during the temporary closure of Salon Mickey. They apply to all Members of the Club and, if the case arises, to the persons who accompany them under the conditions defined hereafter.

Note:

The French government has announced that **Vaccine Pass will be required shortly** for all people aged 16 and over. Disneyland Paris will follow government guidelines accordingly. However, the exact implementation details will not be confirmed until the law publishes the corresponding implementing decrees. You will find all information about the Vaccine Pass on the official French government website. We continue to work closely with the authorities and will share information on how this measure applies to our destination as soon as possible.

Before the Vaccine Pass comes into effect, the Health Pass is still required to access Disneyland Paris. Please visit our website for more details on health and safety measures: <https://www.disneylandparis.com/fr>. Guests in possession of a non-dated ticket or an Annual Pass can now register in our system at <https://www.disneylandparis.com/en-gb/register-tickets/> to obtain a reservation for park entry, prior to arrival on site (subject to availability).

Article 1 – Conditions for allocating Pause Gourmande Vouchers

To be granted Pause Gourmande Vouchers, the Member of the Euro Disney Club must prove to the Cast Member in charge of reception at the window provided for this purpose, that:

- they are Members of the Club by presenting their Euro Disney Club Card
- **they hold entrance tickets to the parks, or an Annual Pass, valid on the day of the Visit**, to Disneyland Park and/or Walt Disney Studios Park.

Members of the Euro Disney Club will be able to benefit from Pause Gourmande Vouchers for themselves and for their Guests (hereafter the “Guests”) and **up to four (4) Guests maximum per Visit** (including children).

Each Guest must also justify his/her entrance to the Parks with tickets or an Annual Pass as well as entry reservation (see conditions above), valid for the same day of the Visit at Disneyland Park and/or Walt Disney Studios Park.

In any case, the **Guests will only be able to benefit from the Pause Gourmande Vouchers as long as one or more Members of the Club accompanies them and if they presents themselves all together at the window.** In addition, the allocation of Pause Gourmande Vouchers to Members of the Club, whether accompanied or not by Guests, are limited to **four (4) allocations per month. Only one allocation is authorized per day** during the window opening hours as defined in Article 2 of the Internal Regulations.

Article 2 – Opening hours or closure of the window

The window will be open **only between Monday January 24, 2022, and Sunday February 20, 2022 inclusive** in the morning **from 9:00 a.m. to noon.**

Euro Disney Associés S.A.S. has the right to stop the distribution of these Vouchers temporarily or indefinitely for any reason, at any time and without prior notice.

Article 3 – Conditions of use of the Pause Gourmande Vouchers

The Pause Gourmande Vouchers give the right to one (1) hot or cold drink and one (1) sweet snack according to the conditions as indicated on the Pause Gourmande Vouchers (dates and places of validity, products offered). Only one Pause Gourmande Voucher per Club Member and per Guest will be allocated according to the conditions of article 1.

Article 4 – Posting

Article 5 – Failure to comply with internal regulations of Salon Mickey and Disneyland Paris site rules ⁽¹⁾

In case of violation of these internal regulations and/ or Disneyland Paris site rules, the Cast Member in charge of the reception at the window will remind Members of the Club and, if the case arises, their Guests, of their obligation to comply with these regulations. The Cast Member may, depending on the situation, refuse the Voucher allocation, instruct them verbally to immediately cease their misbehavior or their disruption, and if deemed necessary will call the Security Department of Disneyland® Paris.

In case of serious and /or repeated breach of the internal regulations, the Cast Member in charge of the reception will also inform the Euro Disney Club team and the responsible party will face sanctions that can include final exclusion from the Euro Disney Club, without notice.
